

## LIMITED WARRANTY

Mallard Marine Corporation warrants, as its SOLE OBLIGATION and the original purchaser's EXCLUSIVE REMEDY, to the original purchaser only of the Marsh Rat that, should it prove defective by reason of improper workmanship and/or material:

1. For one (1) year from the date of the original purchase at retail, the warrantor will repair or replace, at the warrantor's option, any defective part without charge for the part. Parts used for replacement are warranted for the remainder of the original warranty period.

2. During the warranty period, the warrantor will provide the labor for a warranty repair without charge when the consumer delivers the product to warrantor.

a. TO OBTAIN WARRANTY SERVICE, the consumer must deliver the product to the warrantor. Shipping expenses are the purchaser's responsibility. Proof of purchase is required when requesting warranty service. Purchaser must present the sales receipt or other document that establishes proof of purchase. THE RETURN OF THE OWNER REGISTRATION CARD IS NOT A CONDITION OF WARRANTY COVERAGE. However, please detach and return the Owner Registration Card below so that Mallard Marine Corporation can contact you should a question of safety arise that could affect you.

b. THIS WARRANTY DOES NOT COVER defects caused by: modification, alteration, repair or service of the enclosed product by anyone other than warrantor or; physical abuse to, careless handling or misuse of, the product or operation of it in a manner contrary to the accompanying instructions; or shipment of the product to warrantor for service. This warranty also excludes all damages and costs arising from installation, use of the product on other products, materials or goods of any kind.
